SEPARATE LIMITED PARTNERSHIPS (JERSEY) ORDER 2011

THE MINISTER FOR ECONOMIC DEVELOPMENT, in pursuance of Articles 15, 18 and 43 of the [Separate Limited Partnerships \(Jersey\) Law 2011](#), and having consulted the Jersey Financial Services Commission, orders as follows –

1 Interest prescribed

The interest payable on payments representing –

- (a) a share of profits pursuant to Article 15 of the [Separate Limited Partnerships \(Jersey\) Law 2011](#); or
- (b) a return of a limited partner's contribution pursuant to Article 18 of that Law,

shall be simple interest calculated at 2 percentage points above the base rate from time to time of Barclays Bank plc.
