## STATUTORY NUISANCES (JERSEY) REGULATIONS 2017

THE STATES, in pursuance of Article 3 of the [Statutory Nuisances \(Jersey\) Law 1999](#), have made the following Regulations –

### 1 Statutory nuisance of feeding wild animals, birds etc.

The feeding of any wild animal, bird, insect, reptile or fish in such a place or manner as to be prejudicial to health or a nuisance constitutes a statutory nuisance under Article 2(1)(m) of the [Statutory Nuisances \(Jersey\) Law 1999](#).

#### 1A Statutory nuisance of gatherings of persons<sup>1</sup>

- (1) An event at which persons gather constitutes a statutory nuisance, under Article 2(1)(m) of the [Statutory Nuisances \(Jersey\) Law 1999](#), if the event is of such size or duration, and is held in such circumstances in relation to potential contamination or infection with Covid-19, as to be prejudicial to health or a nuisance.<sup>2</sup>
- (2) This Regulation expires at the end of 30th April 2022.<sup>3</sup>

### 2 Citation

These Regulations may be cited as the Statutory Nuisances (Jersey) Regulations 2017 and shall come into force 7 days after they are made.
