## PROCEEDS OF CRIME (SUPERVISORY BODIES) (DESIGNATION OF SUPERVISORY BODIES) (JERSEY) ORDER 2008

**THE MINISTER FOR ECONOMIC DEVELOPMENT**, on the recommendation of the Jersey Financial Services Commission and in pursuance of Article 6 of the <u>Proceeds of Crime (Supervisory Bodies) (Jersey) Law 2008</u>, orders as follows –

### 1 Interpretation

In this Order "principal Law" means the <u>Proceeds of Crime (Supervisory Bodies) (Jersey)</u> <u>Law 2008</u>.

## 2 Designation of the Commission as supervisory body in respect of prescribed persons and businesses

- (1) The Commission is designated as a supervisory body.
- (2) A prescribed person is
  - (a) a person carrying on a Schedule 2 business, other than a person mentioned in Article 5 of the principal Law; and
  - (b) a prescribed NPO.<sup>1</sup>
- (3) The Commission shall exercise supervisory functions in respect of
  - (a) any prescribed person; and
  - (b) any supervised business carried on by a prescribed person.<sup>2</sup>
- (4) The Commission shall have all supervisory functions in relation to any prescribed person.

This Order may be cited as the Proceeds of Crime (Supervisory Bodies) (Designation of Supervisory Bodies) (Jersey) Order 2008.
