# AIRCRAFT REGISTRATION (FEES) (JERSEY) ORDER 2015

**THE MINISTER FOR ECONOMIC DEVELOPMENT**, in pursuance of Article 65(g) of the <u>Aircraft Registration (Jersey) Law 2014</u>, orders as follows –
