## **1 Interpretation**

In this Order, reference to a regulation by number is to the regulation of that number in the [Pet Travel Scheme \(Jersey\) Regulations 2011](#).

## **2 Fees prescribed<sup>1</sup>**

In respect of the exercise of a function –

- (a) described by an item in column 1 of the table;
- (b) under a provision specified in the corresponding entry in column 2 of the table, the fee prescribed is the amount stated in the corresponding entry in column 3 of the table.

<b>Column 1</b> <b>Item number and function exercised</b>	<b>Column 2</b> <b>Provision under which exercised</b>	<b>Column 3</b> <b>Fee</b>
1 – Authorisation or appointment of veterinarian	Regulation 2(1)(a)	£113
2 – Approval of carrier	Regulation 3(2)	£424
3 – Approval for bringing non-compliant animal into Jersey	Regulation 3(3)	£164
4 – Supply of blank identification document	Article 23 of the Community Regulation	£4.70
