CREMATION (FEES) (JERSEY) ORDER 2007

THE MINISTER FOR HEALTH AND SOCIAL SERVICES, in pursuance of Article 4 of the [Cremation \(Jersey\) Law 1953](#), orders as follows –

Commencement [[see endnotes](#)]

1 Cremation fee

The fee for cremating the remains of a person is –

- (a) nil if the person was under 18 years of age at death; or
- (b) £738.50 in any other case.¹

2 Medical certificate fee

The maximum fee that a registered medical practitioner may charge for completing the medical certificate required by Regulation 6(a) of the [Cremation \(Jersey\) Regulations 1961](#) and set out in Schedule 2 or 3 to the Regulations is £82.²

3 Citation

This Order may be cited as the Cremation (Fees) (Jersey) Order 2007.
