CHILD ABDUCTION AND CUSTODY (PARTIES TO CONVENTIONS) (JERSEY) ORDER 2006

THE CHIEF MINISTER, in pursuance of Articles 4 and 14 of the [Child Abduction and Custody \(Jersey\) Law 2005](#), orders as follows –

Commencement [[see endnotes](#)]

1 Parties to the Hague Convention

- (1) For the purposes of the Hague Convention as it has force of law under Part 2 of the [Child Abduction and Custody \(Jersey\) Law 2005](#), the Contracting States to that Convention (other than the United Kingdom) are as specified in column 1 of Schedule 1.
- (2) Where the Hague Convention applies, or applies only, to a particular territory or particular territories specified in a declaration made by a Contracting State under Article 39 or Article 40 of the Hague Convention, the territory or territories to which it applies are as specified in column 2 of Schedule 1.
- (3) The date of the coming into force of the Hague Convention as between Jersey and any State or territory specified in Schedule 1 is as specified in column 3 of that Schedule.

2 Parties to the European Convention

- (1) For the purposes of the European Convention as it has force of law under Part 3 of the [Child Abduction and Custody \(Jersey\) Law 2005](#), the Contracting States to that Convention (other than the United Kingdom) are as specified in column 1 of Schedule 2.
- (2) Where the European Convention applies, or applies only, to a particular territory or particular territories specified in a declaration made by a Contracting State under Article 24 or Article 25 of the European Convention, the territory or territories to which it applies are as specified in column 2 of Schedule 2.
- (3) The date of the coming into force of the European Convention as between Jersey and any State or territory specified in Schedule 2 is as specified in column 3 of that Schedule.

3 Citation

This Order may be cited as the Child Abduction and Custody (Parties to Conventions) (Jersey) Order 2006.
