MOTOR TRAFFIC (CABS – FARES AND CHARGES) (JERSEY) ORDER 2017

THE MINISTER FOR INFRASTRUCTURE, in pursuance of Articles 38 and 46 of the <u>Motor Traffic (Jersey) Law 1935</u>, orders as follows –

Commencement [see endnotes]

1 Interpretation

In this Order, unless the context otherwise requires -

"bank holiday" has the same meaning as in the <u>Public Holidays and Bank Holidays</u> (Jersey) Law 1951;

"cab" means -

- (a) a private-hire cab, within the meaning of the <u>Motor Traffic (Taxi-Cabs –</u> <u>General) (Jersey) Order 2002;</u> or
- (b) a taxi, within the meaning of that Order;

"public holiday" has the same meaning as in the <u>Public Holidays and Bank</u> <u>Holidays (Jersey) Law 1951</u>.

2 Hire charge for cabs

The maximum hire charge for the hire of a cab shall be calculated and charged in accordance with the table of fares and charges set out in the table in the Schedule, unless -

- (a) a different hire charge is agreed by the customer, being the person who agrees to hire the cab, with the driver of the cab before the journey commences; or
- (b) the hire is booked through a third party (whether an individual or organization) other than the driver and the hire charge is calculated in accordance with charges which, before the cab is booked, have been
 - (i) notified to the Minister, and
 - (ii) published by the third party in such a way that the charges have been reasonably brought to the attention of the public.

3 Period of hire

- (1) For the purpose of calculating the hire charge for the hire of a cab the period of hire shall be taken as starting when a passenger enters the cab unless the cab has been summoned to a place when it shall be taken as starting when it arrives at that place.
- (2) The period of hire ends when the hire charge is tendered.

4 Citation

This Order may be cited as the Motor Traffic (Cabs – Fares and Charges) (Jersey) Order 2017.

For each 45 seconds, whether consecutive or not, during which the cab is stationary –	32p.

• after 7 p.m. on 24th December but before 7 a.m. on 27th December; o	r		
• after 7 p.m. on 31st December but before 7 a.m. on 2nd January			
Distance fare –			
For the first 176 yards or any shorter journey –			
For each additional 176 yards or part of any additional such distance –	35p		
Waiting charge –			
For each 28 seconds, whether consecutive or not, during which the cab is stationary –	35p.		
Additional charges			
1. For each passenger in excess of 4 passengers being carried	£1.00		
2. For every fare not paid in cash	50p.
