PART 1

NOTICE OF APPLICATION FOR ADMINISTRATION ORDER

1 Timing of notice

Unless otherwise ordered by the court, notice of an application under Article 143F(5) of the [Companies \(Jersey\) Law 1991](#) must be given at least 5 working days before the application is to be heard.

2 Content of notice

Notice of an application under Article 143F(5) of the [Companies \(Jersey\) Law 1991](#) must include –

- (a) the name and address of the company;
- (b) the date, time and location of the application;
- (c) the name and address of the proposed administrator;
- (d) a summary of the grounds for the application and the purposes of the administration order;
- (e) that the person receiving the notice may attend court to make representations before an order is made;
- (f) the name and address of the applicant, and their standing to make the application, including details of the debt if the applicant is a creditor.

3 Ability to dispense with notice

Notice of an application under Article 143F(5) of the [Companies \(Jersey\) Law 1991](#) need not be given to a person who has previously indicated in writing to the applicant that notice does not need to be given.
