### **1 Fee for commercial seaweed licence<sup>1</sup>**

For the purposes of Regulation 4(1) of the [Aquatic Resources \(Seaweed Licences\) \(Jersey\) Regulations 2019](#), the fee to accompany an application for a licence, including renewal of a licence, to harvest seaweed by hand for commercial purposes is £106.

### **2 Citation and commencement**

This Order may be cited as the Aquatic Resources (Seaweed Licence Fees) (Jersey) Order 2019 and comes into force on the day after the day this Order is made.
